1. All advanced green fee program cards expire on November 30th annually.
2. The advanced green fee card is valid for the individual whose name appears on the card. The ID card issued to the Advanced Green Fee Program participant must be presented to the pro shop attendant before playing. This card contains a picture of the participant and a computer bar code that interfaces with the cash register.
3. The advanced green fee program is green fees paid in full in advance as specified in the golf course fee schedule. Certain restrictions apply. Installment payments are not permitted. During the months of December 1 through April 14, the Advanced Green Fee Program participant must purchase a green fee at a special surcharge rate to play each eighteen (18) or nine (9) hold round of golf. 4. The advanced green fee program participants shall be offered a computerized golf handicap upon request. Handicap record fees are included in the cost of the advanced green fee program. Advanced green fee program participants shall receive 10% off of regularly priced merchandise, excluding golf balls, gloves and golf tees.
5. Advanced green fees are not valid for any organized tournament or league play. Approved associations are exempted from this limitation.
6. The advanced green fee shall not be transferable or refundable except as defined in this application form. The Parks and Recreation Department director or designee may refund advanced green fees under the terms of the present policy. Request for expiration date extensions will not be honored for any reason.
7. REFUND POLICY: A request for refund on unused portions of a pre-paid greens fee will ONLY be considered in the case of death or a bonafide medical reason, which must be accompanied with a letter supporting the condition from a medical doctor. In the case of two (2) additional pre-paid fees, if one family member is affected there will be no refunds. A request for refund will be submitted to the golf course manager with supporting documents. The following pro-rated schedule will apply if the request is approved:
 - a. Nine (9) or more months remaining unused – 50% Refund
 - b. Six (6) to eight (8) months remaining unused – 30% Refund
 - c. Four (4) to five (5) months remaining unused – 15% Refund
 - d. Three (3) months or less unused – no refund
8. Patrons purchasing an advanced green fee card must abide by all rules and regulations established by the resolution governing the golf courses. Continuous abuse or violations concerning the golf course rules could result in the revocation or non-renewal of the individuals advanced green fee card.
